KURAMAN ISLAND—NEW LIGHT.

THE new light-house in course of erection on the summit of Kuraman Island consists of a steel tower, braced column, 50 feet high, painted white, dome red, and will exhibit, at an elevation of 215 feet above High Water, a white flashing light, showing one flash of $\frac{1}{2}$ second duration every 5 seconds. Visible (except where obscured by Labuan Island) 21 miles.

The light is Dioptric 3rd Order, I. O. B. 70,000 Candle Power.

Approximate position :—Latitude, 5° 13' 25" N.
Longitude, 115° 7' 30" E.

It is expected the light will be established about December next. Further notice will be issued.

FRANKLIN HARBOR.

MASTERS of Vessels and others are hereby informed that the Channel, which has been dredged to the new Jetty at Franklin Harbor, runs in the line of the Jetty $319\frac{1}{2}^{\circ}$ (N. 45° W. Mag.) for a distance of 1.3 miles, and has not less than 12 feet at L.W.S. over a full width of 100 feet. It is marked by three (3) black buoys, to be kept on the port hand entering ; and one (1) red buoy and one (1) black and red chequered buoy on the starboard hand. The chequered buoy marks the point where the new channel deviates from the old, and is to be kept on the port hand entering when using the latter. The inner black buoy, which also marks the South-Eastern extreme of the swinging basin, is so moored and fitted that it may be used as a haul-off buoy for vessels at the Jetty.

Approximate position of end of Jetty—Latitude, $33^{\circ} 41\frac{1}{4}'$ S. ; Longitude, $136^{\circ} 56\frac{1}{4}'$ E.
