No tender will be considered unless the person tendering produces a receipt to the effect that he has deposited in the Colonial Treasury the sum of \$200, as a pledge of the bonâ fides of his offer, which sum shall be forfeited to the Crown, if such person shall refuse to carry out his tender, should the tender be accepted.
