The new light on Cape Bruce, Peter the Great Bay, was exhibited on 1st October (O.S.).

It is situated in Lat: 42° 52′ 55″ N. Long: 131° 28′ 12″ E. It is an occulting light visible 18 miles, and shows White between N. 36° E. and N. 54° E. and between S. 54° E. and S. 18° E., Red between N. 54° E. and S. 54° E., and Green between S. 18° E. and S. 46° W. and between N. 81° W. and N. 36° E.

The period of eclipse is 7.5 seconds every 15 seconds.

A Fog Bell has also been installed.

YANGTZE RIVER-CHINKIANG AND SHANGHAI DISTRICTS.

JOHNSON FLATS-LANGSHAN CROSSING.

Buoy Established; Upper Crossing Buoy moved.

NOTICE is hereby given that the following changes have been made in the buoyage of the eastern edge of the Johnson Flats:—

A 6-foot conical Buoy, painted black, and named the Pagoda Buoy, is now moored in 33 feet of water at low water of spring tides, to mark the eastern edge of the Johnson Flats. From the Buoy, Langshan Pagoda bears N. 82\frac{3}{4}\cdot E., distant 3.9 miles.

The Upper Crossing Buoy has been moved 1.5 cables to the eastward of its former position, owing to the extension of the Johnson Flats. The Buoy is now moored in 28 feet of water at low water of spring tides.

Langshan Pagoda bears N. 56° E., distant 5.25 miles.

Caution.

A recent examination of the Langshan Crossing shows that in the vicinity of the Upper Crossing Buoy the channel has now a breadth of only $3\frac{1}{2}$ cables between the 5-fathom contours, and that the Crossing in general is in a state of rapid change.

All bearings given are magnetic.
