(2) rags. (Refuse of new goods coming direct from the weaving-mills, from workshops where apparel is made or from bleaching establishments, artificial wool, and cuttings of new paper, are not considered as rags.) Quarantine up to 21 days according to the state of health on board the ships but subject to exemption on production of certificates legalised by the Netherlands Consul-General at Hongkong. | 23rd May, 1913. | No. S. 147. |
| Bangkok. | Hongkong declared a Plague-infected port. Vessels coming from Hongkong must remain in Quarantine Anchorage, Kohphra, until ten days have elapsed from time of leaving Hongkong. | 20th March, 1914. | No. S. 82. |
