BE it enacted by the Governor of Hongkong, with the advice and consent of the Legislative Council thereof, as follows:--

- 1. This Ordinance may be cited as "The British Short title. Traders Insurance Company Limited (Capital Conversion) Ordinance, 1919"
- 2. In this Ordinance, "the Company" means the Interpretation.

- 3. The Company may at any time by special resolution convert into gold its silver capital as existing at the date of the confirmation of such special resolution, and such conversion shall take effect upon such special resolution being confirmed. 4. Upon the filing of any such special resolution as Issue of is referred to in section 3 of this Ordinance the Registrar of Companies shall issue a fresh certificate of incorporation of the Company shewing the capital of the Company as effected by such conversion. Such fresh certificate shall take the place of the original certificate of incorporation of the Company and shall be the certificate of incorporation of the Company.
