

Successors or Assigns, signified in writing by the Governor, then it shall be lawful for His Majesty, His Heirs, Successors or Assigns, by the Governor or by any Officer authorized by him in writing, to re-enter on the land, foreshore, and sea bed included in and demised by such leases or any portion thereof in the name of the whole, and thereupon the same shall be forfeited to and vest in the Crown; the leases will also contain in particular a reservation to the Crown of all mines and minerals under the demised land.

3. The lessees of the Lots will also have to pay the sum of \$6.25 for each new boundary stone to define the Lots, and \$30 for each Crown Lease.
