**Chinese Maritime Customs—Marine Department  
River Administration.**

*Notices to Mariners; Defined Limits of Control.*

NOTICE is hereby given that on and after the 20th May, 1921, the administration of the Yangtze River by the Marine Department of the Chinese Maritime Customs will be divided into the following administrative areas, in so far as the issue of Notices to Mariners is concerned.

The Yangtze River from Vine Point to and including the area controlled by the Hankow Harbour Authorities will be under one administration, the head office for which will be the River Inspector's Office at Kiukiang, with sub-offices (District River Inspectors' Offices) at Hankow and Wuhu. All Notices to Mariners issued by this administration will be headed "Lower Yangtze River."

The Yangtze River from the upper limit of the area controlled by the Hankow Harbour Authorities to and including Ichang Harbour and the tributary Siang and Yuan Rivers, also the Tungting Lake, will be under one administration, the head office for which will be the River Inspector's Office at Yochow. Notices to Mariners issued by this administration will be headed "Middle Yangtze River."

The Yangtze River from the upper limit of Ichang Harbour to Chungking will be under one administration, the head office for which will be the River Inspector's Office at Chungking, and all Notices to Mariners issued by this administration will be headed "Upper Yangtze River."
