Conservancy Works in the Min River between Nantai and Kushan Point.

Referring to Notice No. 153 notice is hereby given that the two anchored sampans marking the limits of the Channel opposite Gong Bien and Puo A which were withdrawn on the 1st May, 1923, will be replaced on the 1st September.

The signals shown by these sampans will be the same as before, viz.:—each point will be marked by an anchored sampan, displaying a red flag by day and two white lights, one vertically above the other, at night.

As three of these sampans will now temporarily mark the Channel between Nantai and Kushan Point, vessels ascending the river should leave the lower or down stream mark on the starboard side and the middle and upper marks on the port side. These marks will be moved from time to time as the Channel changes and this stretch of the river should be navigated with caution as the marks are only approximately correct. In the event of bad weather these sampans may have to be temporarily removed.
