Haitan Strait Approaches.

Rocky Patch Located in Dwaft Anchorages.

Notice is hereby given that a rocky patch has been located by the revenue steamer *Haihsing* in latitude 25° 27′ 29″ N., longitude 119° 49′ 50″ E.

From the centre of the patch, Hai Head bears N. 77° E., distant 9.9 cables.

The least water found on the patch was 7 feet, reduced to low water of spring tides.

The patch is small in extent and the bottom very uneven.

Soundings on the patch ranged from 7 feet 16 feet, reduced to low water of spring tides.

The patch is in close proximity to the $4\frac{3}{4}$ -fathom patch on British Admiralty Chart No. 818.

All bearings given are magnetic.

Mariners and others are hereby notified that it is intended to alter the period and to increase the power of the light on Cape Leeuwin.
