CHINA STATION HYDROGRAPHICAL MEMORANDA.

37. Borneo-North West Coast-Muara Harbour.

Remarks—The conspicuous tree on Pisang Hill has disappeared.

Sarasap village is invisible from seaward and is of no use as a leading mark.

Brooketon wharf lies in a N.E. direction and is approximately 140 feet long.

The beacons on Muara bar are surmounted by top marks painted white and red, white on safe side and red on shoal side of the beacon.

On 30th October, 1924, one of the four beacons marking the bar had disappeared and one was in ruins.

With reference to China Sea Pilot, Volume IV, 1923, page 120, Iroquois took in 104 tons of coal in 2 hours alongside the wharf.

The General manager of the Kutch factory, Brunnei, reports that Anson passage is silting up.
