# 40. China, East Coast—Gulf of Pechili.

Shoal point.

(Latitude 39° 57′ N., Longitude 119° 48′ E.).

Remarks—Shoal water off Shoal Point is reported to extend at least two miles from the extremity of the Point.

# 41. Approaches to Port Swettenham—Entrance to the South Klang Strait.

Establishment of a beacon.

A beacon has been erected 0° from the lighthouse at Pinto Gedong, distant 300 yards. Approximate position Latitude 2° 54′ N., Longitude 101° 15′ E., on chart No. 3,453.

This beacon, which is painted white, in line with the black legs of the tripod structure lighthouse, leads over the bar in not less than 25 feet at L.W.O.S.

Course should be altered when about six cables from the lighthouse so as to steer for the black and white beacon on the eastern shore of the strait, bearing N. 50 E. until the beacon on first point is abeam, and thereafter a mid-channel course may be steered.

### Buoy to be moved.

The present bar buoy is to be moved  $7\frac{1}{2}$  cables  $204^{\circ}$  from its present charted position; it will then mark the outer end of the 25-ft. channel.

# Temporary buoy to be established.

A small white buoy with a spherical topmark is to be established in a position 173° 7 cables from the lighthouse.

This buoy, which will be experimental, will mark the turning point from the beacon and lighthouse in line bearing north, to the N. 50 E. course into the strait.
