LOCAL NOTICE TO MARINERS.

HANKOW DISTRICT.

No. 2 of 1925.

Position of Shoals in the Hankow Harbour.

With reference to Local Notice to Mariners, Hankow District No. 1 of 1925, notice is hereby given that the shoals mentioned therein have altered in position, and that Sections VIII, IX and X are now affected by a shoal, six cables in length and half a cable wide, which extends from Messrs. Butterfield & Swire's Lower Property to the Italian Consulate, and distant only one cable from the Hankow Bund. This shoal carries 13 feet less than the Hankow Watermark.
