ETTERS PATENT under the Great Seal appointing SIR HERCULES GEORGE ROBERT ROBINSON, Knight, to be Governor and Commander-in-Chief of the Colony of Hongkong and its Dependencies.

VICTORIA, by the Grace of God of the United Kingdom of Great Britain and Ireland Queen, Defender of faith, To Our trusty and well beloved Hercules George Robert Robinson, Esquire, Greeting: Whereas, by the Letters Patent, under the Great Seal of Our United Kingkom of Great Britain and Ireland, bearing date Westminster, the Fifth Day of April, One Thousand Eight-hundred and Forty-three, in the Sixth Year of Our To. We did make provision for the Government of Our Colony of Hongkong, and of its Dependencies, as upon being thereunto had, will more fully, and at large appear; And Whereas We did by certain other Letters that, under the Great Seal of Our United Kingdom of Great Britain and Ireland, also bearing date at Westster, the Eleventh Day of January One Thousand Eight Hundred and Fifty-four, in the Soventeenth Year of Reign, constitute and appoint Our trusty and well beloved John Bowring, Esquire, now Sir John Bowring, Ith, to be Governor and Commander-in-Chief, in and over Our said Colony of Hongkong, and of its Defences, for and during Our Royal Pleasure: NOW KNOW YOU, that We have revoked and determined, by these Presents, Do revoke and determine, the said last recited Letters Patent, and every Clause, Article, I fining therein contained; And further know you, that We reposing especial trust and confidence in the fence, courage and loyalty, of you the said Hercules George Robert Robinson, of Our especial grace, this knowledge, and mere motion, Have thought fit to constitute and appoint, and do hereby constitute appoint you the said Hercules George Robert Robinson, to be the Governor and Commander-in-Chief and over Our said Colony of Hongkong and its Dependencies, and of all Forts and Garrisons, creeted and Sished within the said Colony for and during Our pleasure; And We do hereby require and command the said Hercules George Robert Robinson, to do and execute all Things that shall belong to your Command and the trust We have reposed in you, according to the several powers and directions granted to the Govern

Powers, Instructions, and Authorities, as shall from time to time and at any time hereafter be granted or appointed you, under Our Signet and Sign Manual, or by Our Order in Our Privy Council, or by Us through one of Our Principal Secretaries of State; And We do hereby require and command all Officers and Ministers, Civil and Military, and all other the Inhabitants of Our said Colony of Hongkong and its Dependencies, to be obedient, aiding, and assisting to you the said Hencurus George Rommer Rommson, in the execution of this Our Commission, and of the Powers and Authorities herein contained. In Witness whereof We have caused these Our Letters to be made Patent. Witness Ourself at Westminster, the Twenty-second Day of June in the Twenty-third Year of Our Reign, By Warrant under the Queen's Sign Manual.

LETTERS PATENT appointing SIR HERCULES GEORGE ROBERT ROBINSON, Knight, to be Vice-Admiral of the Island of Hongkong.

VICTORIA, by the Grace of Gop of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith, To Our beloved Hencules George Robert Robinson, Esquire, Our Governor and Commander-in-Chief in and over Our Island of Hongkong, and its Dependencies, and in the event of his absence, the Officer administering the Government of our said Island and its Dependencies for the time being, Greeting: We confiding very much in your Fidelity, Care and Circumspection in this behalf, do by these Presents, which are to continue during Our pleasure only, ordain, constitute, and depute you, the said Hercules George Robert Robinson, Our Governor and Commander-in-Chief aforesaid, and in the event of your absence, the Officer administering the Government of Our said Island and its Dependencies for the time being, Our Vice-Admiral, Commissary, and Deputy in the Office of Vice-Admiralty in Our Island of Hongkong aforesaid, and Territories thereon depending, and in the Maritimo parts of the same, and thereto adjoining whatsoever, with power of taking and receiving all and every the Fees, Profits, Advantages, Emoluments, Commodities, and Appurtenances whatsoever due and belonging to the said Office of Vice-Admiral, Commissary, and Deputy in Our said Island of Hongkong, and Territories dependent thereon, and Maritime parts of the same and adjoining to them whatsoever, according to the Ordinances and Statutes of Our High Court of Admiralty of England: And We do hereby commit and grant unto you, the aforesaid HERCULES GEORGE ROBERT ROBINSON, Our Governor and Commander-in-Chief aforesaid, and in the event of your absence, the Officer administering the Government of Our said Island, and its Dependencies for the time being, Our Power and Authority in and throughout Our Island of Hongkong afore mentioned and Territories thereof, and Maritime parts whatsoever adjacent thereto, and also throughout all and every the Sca Shores, Public Streams, Ports Fresh Waters, Rivers, Creeks, and Arms as well of the Sca as of the Rivers and Coasts whatsover of Our said Island of Hongkong, and Territories dependent thereon, and Maritime parts whatsoever of the same, and thereto adjacent as well within Liberties and Franchises as without, To take cognizance of and proceed in all Causes, Civil and Maritime, and in Complaints, Contracts, Offences, or Suspected Offences, Crimes, Pleas, Debts, Exchanges, Accounts, Charter-Parties, Agreements, Suits, Trespasses, Injuries, Extertions, and Demands, and Businesses Givil and Maritime whatsoever, commenced or to be commenced, between Merchants, or between Owners and Proprietors of Ships and other Vessels, and Merchants or others whomsoever, with such Owners and Proprietors of Ships and other Vessels, and Merchants or others whomsoever, with such Owners and Proprietors of Ships, and all other Vessels whatsoever employed or used within the Maritime Jurisdiction of Our Vice-Admiralty of Our said Island of Hongkong, and Territories depending on the same, or between any other Persons whomsoever, had, made, begun, or contracted for any Matter, Thing, Cause, or Business whatsoever done or to be done within Our Maritime Jurisdiction aforesaid, together with all and singular their Incidents, Emergencies, Dependencies, annexed and con nexed Causes whatsoever, wheresover, or howsoever, and such Causes, Complaints, Contracts, and other the Premises abovesaid, or any of them, which may happen to arise, be contracted, had, or done, to hear and determine according to the Rights, Statutes, Laws, Ordinances, and Customs, anciently observed; And moreover, in all and singular Complaints, Contracts, Agreements, Causes, and Businesses, Civil and Maritime, to be performed beyond the Sea, or contracted there, howsoever arising or happening, and also in all and singular other Causes and Matters which in any manner whatsoever touch, or any way concern, or anciently have and do or ought to belong unto the Maritime Jurisdiction of Our aforesaid Vice-Admiralty of Our said Island of Hongkong and Territories thereon depending and Maritime parts thereof, and to the same adjoining, whatsoever, and generally in all and singular other Causes and Maritime parts thereof, and to the same adjoining, whatsoever, and generally in an and singular other Causes, Suits, Crimes, Offences, Excesses, Injuries, Complaints, Misdemeanors, or suspected Misdemeanors, Trespasses, Regratings, Forestallings, and Maritime Businesses whatsoever, throughout the places aforesaid, within the Maritime Jurisdiction of Our Vice-Admiralty of Our Island of Hongkong aforesaid and Territories thereon depending, by Sea or Water, or the Banks or Shores of the same, howsoever done, committed, perpetrated, or happening, and also to enquire, by the Oaths of honest and lawful Men of Our said Island of Hongkong, and Territories depending thereon, and Maritime parts of the same and adjoining to them whatsoever, dwelling both within Liberties and Franchises and without, as well of all and singular such matters and things which of right, and by the Statutes Laws. Jurisdiction aforesaid, and to hear, examine, discuss, and finally determine the same, with their Emergencies, Deioneics, Incidents, annexed and connexed Causes and Businesses whatsoever, together with all other Causes Civil Maritime, and Complaints, Contracts, and all and every the respective Premises whatsoever above expressed, acling to the Laws and Customs aforesaid, and by all other lawful Ways, Means, and Methods according to the best of rskill and knowledge, and to compel all manner of Persons in that behalf, as the case shall require to appear, and to ever, with power of using any temporal Coercion, and of inflicting any other Penalty or Mulet according to the Laws Customs aforesaid, and to do and minister Justice according to the right order and course of the Law summarily plainly, looking only into the truth of the fact, and to fine, correct, punish, chastise, and reform, and imprison, cause and command to be imprisoned in any Gaols being within Our Island of Hongkong aforesaid, and mitories thereunto belonging, the parties guilty, and the Contemnors of the Law and Jurisdiction of Our mirally aforesaid, and Violators, Usurpers, Delinquents, and Contumacious Absenters, Masters of Ships, driners, Rowers, Fishermen, Shipwrights, and other Workmen and Artificers whatsoever, exercising any of Maritime Affairs, according to the Rights, Statutes, Laws, Ordinances, and Customs anciently observed; to deliver and absolutely discharge, and cause and command to be discharged, whatsoever Persons imprisoned such Cases who are to be delivered; and to preserve, and cause to be preserved the Public Streams, Rivers, Fresh Water, and Creeks whatsoever within our Maritime Jurisdiction aforesaid, in what Place her they be in Our said Island of Hongkong, and Territories thereunto belonging, and Maritime parts of the and thereto adjacent whatsoever, as well for the preservation of Our Navy Royal, and of the Elects and sels of Our United Kingdom and Dominions aforesaid, as of whatsoever Fishes increasing in the Rivers and ses aforesaid; and also to keep, and cause to be executed, and kept in our said Island of Hongkong, and Tertries thereunto belonging, and Maritime parts thereof, and thereto adjacent whatsoever, the Rights, Statutes, Laws, linances, and Customs anciently observed, and to do, exercise, expedite, and execute all and singular other Things the Premises, and every of them, as they by right and according to the Laws and Statutes, Ordinances, and Customs resaid should be done; And moreover to reform Nets too close and other unlawful Engines or Instruments whatso-rior the catching of Fishes wheresoever, by Sea or Public Streams, Ports, Rivers, Fresh Waters, or Creek whatsoor throughout Our Island of Hongkong aforesaid, and Territories dependent thereon, and Maritime parts of the and thereto adjacent, used or exercised by Water within Our Maritime Jurisdiction aforesaid wheresoever, and punish and correct, the Exercisers and Occupiers thereof according to the Statutes, Laws, Ordinances, and Custom resaid; and to pronounce, promulge, and interpose all manner of Sentences, and Decrees, and to put the same in vention with Cognizance, and Jurisdiction of whatsoever other Causes, Civil and Maritime, which relate to the Sea, which any manner of Ways respect or concern the Sea, or Passago over the same, or Naval, or Maritime Voyages, .
