

No. 4 of 1859.

#### TUESDAY, 22d FEBRUARY, 1859.

#### PRESENT:

- EXCELLENCY THE GOVERNOR AND ALL THE MEMBERS, EXCEPT THE ACTING ATTORNEY GENERAL, AND THE CHIEF MAGISTRATE WHO WAS ABSENT ON ACCOUNT OF PRESS OF BUSINESS AT THE MAGISTRACY.
- Council met to-day by Special Summons.
- Minutes of the Council held on the 4th instant, were read and approved.
