Merchant Ships, (with the exception of those calling for Orders, and whose stay in Port will not exceed from to three days,) will keep their Topgallant Masts and Yards on Deck, Flying Jibboom in, and particular

ntion must be paid to keep their Hawse clear,

As some Ships now in Harbour are moored in a most slovenly manner, so slack that it is impossible to keep - Chains from twisting, the Harbour Master finds it necessary to state that, in mooring Vessels, Masters are fired to veer out Ninety Fathoms of Chain on their first anchor, and when taut in the required direction, then their second anchor, vecring out on that Chain, and heaving in Forty-five Fathoms of their first.

Persons neglecting these precautionary measures will be subject to the full penalty provided in Section VIII
