VOTES AND PROCEEDINGS OF THE LEGISLATIVE COUNCIL OF HONGKONG.

No. 11 of 1863.

WEDNESDAY, 28^{TH} OCTOBER, 1863.

PRESENT:

His Excellency the Acting Governor and all the Members, except the Acting Chief Justice absent on vacation leave, and the Attorney General and Mr. Perceval, absent on account of indisposition.

The Council met to-day by Special Summons.

The Minutes of the Council held on the 8th July were read and approved.

The Acting Governor laid on the Table a Printed Copy of the Draft of a Bankruptcy Ordinance for Hongkong which the Secretary of State, at the suggestion of Sir Hercules Robinson, had ordered to be prepared at Home, (and which by His Grace's direction had been drafted by the Honorable Mr. Bourke, Parrister-at-law,) in substitution for the proposed Insolvent Debtor's Ordinance which was read for form's sake a first time in the Legislative Council on the 17th December last; and His Excellency now moved that the Bill on the Table, entitled, "An Ordinance to amend the Law of Debtor and Creditor in the Colony of Hongkong," be this day read a first time.

Question put and carried.

Bill read a first time, and ordered to be read a second time on Monday, the 16th November.

His Excellency communicated to the Council the remarks of the Secretary of State in a Despatch recently received as to the framing of the Gaol Regulations under Ordinance No. 4 of 1863, as also the reply which he had given to His Grace in explanation of those remarks.

The Council then adjourned to Monday, the 16th Proximo.

Title.

An Ordinance to amend the Law relating to the fraudulent marking of Merchandise,

, 1863.]

Preamble.

Whereas it is expedient to amend the Laws relating to the fraudulent marking of Merchandise, and to the Sale of Merchandise falsely marked for the Purpose of Fraud: Be it therefore enacted by His Excellency the Acting Governor of Hongkong with the advice of the Legislative Council thereof as follows:

Construction of

I. In the Construction of this Ordinance the Word "Person" shall include any Person, whether a Subject of Her Majesty or not, and any Body Corporate or Body of the like Nature, whether constituted according to the Law of this Colony or of any of 'Her Majesty's Colonies or Dominions, or according to the Law of any Foreign Country, and also any Company, Association, or Society of Persons, whether the Members thereof be Subjects of Her Majesty or not, or some of such Persons Subjects of Her Majesty and some of them not, and whether such Body Corporate, Body of the like Nature, Company, Association, or Society be established or carry on Business within Her Majerty's Dominions or elsewhere, or partly within Her Majesty's Dominions and partly elsewhere; the Word "Mark" shall include any Name, Signature, Word, Letter, Device, Emblem, Figure, Sign, Seal, Stamp, Diagram, Label, Ticket, or other Mark of any other Description; and the Fxpression "Trade Mark" shall include any and every such Name, Signature, Word, Letter, Device, Emblem, Figure, Sign, Seal, Stamp, Diagram, Label, Ticket, or other Mark as aforesaid lawfully used by any Person to denote any Chattel, or any Article of Trade, Manufacture, or Merchandise, to be an Article or Thing of the Manufacture, Workmanship, Production, or Merchandise of such Person, or to be an Article or Thing of any peculiar or particular Description made or sold by such Person, and shall also include any Name, Signature, Word, Letter, Number, Figure, Mark, or Sign which in pursuance of any Statute or Statutes, Ordinance or Ordinances for the Time being in force relating to registered Designs is to be put or placed upon or attached to any Chattel or Article during the Existence or Continuance of any Copyright or other sole Right acquired under the Provisions of such Statutes or Ordinances or any of them.

Forging a Trade

II. Every Person who, with Intent to defraud, or to enable another to defraud any Mark or falsely apply-Person, shall forge or counterfeit, or cause or procure to be forged or counterfeited, any with Intent to defraud, Trade Mark, or shall apply, or cause or procure to be applied, any Trade Mark or any forged or counterfeited Trade Mark to any Chattel or Article not being the Manufacture, Workmanship, Production, or Merchandise of any Person denoted or intended to be denoted by such Trade Mark, or denoted or intended to be denoted by such forged or counterfeited Trade Mark, or not being the Manufacture, Workmanship, Production, or Merchandise of any Person whose Trade Mark shall be so forged or counterfeited, or shall apply, or cause or procure to be applied, any Trade Mark or any forged or counterfeited Trade Mark to any Chattel or Article, not being the particular or peculiar Description of Manufacture, Workmanship, Production or Merchandise denoted or intended to be denoted by such Trade Mark, or by such forged or counterfeited Trade Mark, shall be guilty of a Misdemeanor, and every Person so committing a Misdemeanor shall also forfeit to Her Majesty every Chattel and Article belonging to such Person to which he shall have so unlawfully applied, or caused or procured to be applied, any such Trade Mark or forged or counterfeited Trade Mark as aforesaid, and every Instrument in the Possession or Power of such Person, and by means of which any such Trade Mark, or forged or counterfeited Trade Mark as aforesaid, shall have been so applied, and every Instrument in the Possession or Power of such Person for applying any such Trade Mark or forged or counterfeited Trade Mark as aforesaid, shall be forfeited to Her Majesty; and the Court before which any such Misdemeanor shall be tried may order such forfeited Articles as aforesaid to be destroyed or otherwise disposed of as such Court shall think

Applying a forged III. Every Person who, with Intent to defraud, or to enable another to defraud, sel, Case, wrapper, any Person, shall apply or cause or procure to be applied any Trade Mark or any

forged or counterfeited Trade Mark to any Cask, Bottle, Stopper, Vessel, Case, Cover, &c., in or with which Wrapper, Band, Reel, Ticket, Label, or other Thing in, on, or with which any Chattel intended to be sold, a or Article shall be intended to be sold or shall be sold or uttered or exposed for Sale, Misdeamenor. or intended for any Purpose of Trade or Manufacture, or shall enclose or place any Chattel or Article, or cause or procure any Chattel or Article to be enclosed or placed, in, upon, under, or with any Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing to which any Trade Mark shall have been falsely applied, or to which any forged or counterfeited Trade Mark shall have been applied, or shall apply or attach or cause or procure to be applied or attached to any Chattel or Article any Case, Cover, Reel, Ticket, Label, or other Thing to which any Trade Mark shall have been falsely applied, or to which any forged or counterfeited Trade Mark shall have been applied, or shall enclose, place, or attach any Chattel or Article, or cause or procure any Chattel or Article to be enclosed, placed, or attached, in, upon, under, with, or to any Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing having thereon any Trade Mark of any other Person shall be guilty of a Misdemeanor, and every Person so committing a Misdemeanor shall also forfeit to Her Majesty every such Chattel and Article, and also every such Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing as aforesaid in the Possession or Power of such Person; and every other similar Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing made to be used in like manner as aforesaid, and every Instrument in the Posterior of Power of the Posterior of session or Power of such Person, and by means of which any such Trade Mark or forged or counterfeited Trade Mark as aforesaid shall have been applied, and also every Instrument in the Possession or Power of such Person for applying any such Trade Mark or forged or counterfeited Trade Mark as aforesaid, shall be forfeited to Her Majesty; and the Court before which any such Misdemeanor shall be tried may order such forfeited Articles as aforesaid to be destroyed or otherwise disposed of as such Court shall think

V. Every Addition to and every Alteration of, and also every Imitation of any Additions to and Trade Mark which shall be made, applied, or used with Intent to defraud, or to enable Marks made with any other Person to defraud, or which shall cause a Trade Mark with such Alteration Intent to definud to or Addition, or shall cause such imitation of a Trade Mark to resemble any genuine Trade Mark so or in such Manner as to be calculated or likely to deceive, shall be and be deemed to be a false, forged, and counterfeited Trade Mark within the Meaning of this Ordinance; and every Act of making, applying, or otherwise using any such Addition to or Alberation of a Trade Mark or any such Imitation of a Trade Mark as aforesaid done by any Person with Intent to defraud, or to enable any other Person to defraud, shall be and be deemed to be forging and counterfeiting a Trade Mark within the Meaning of this Ordinance.

VI. Where any Person who, at any Time after the Thirty-first Day of March Any Person who, after 31st March 1864, One thousand eight hundred and sixty-four, [or after such earlier day to be specified as shall have sold an One thousand eight hundred and sixty-lour, for after Sale or other Purpose as aforesaid, Article having a false aforesaid] shall have sold, uttered, or exposed for Sale or other Purpose as aforesaid, Trade Mark to be or shall have caused or procured to be sold, uttered, or exposed for Sale or other bound to give Inform-Purpose as aforesaid, any Chattel or Article, together with any forged or counterfeited red it;

Trade Mark, or together with the Trade Mark of any other Person used without lawful Authority or Excuse as aforesaid, and that, whether any such Trade Mark, or such forged or counterfeited Trade Mark as aforesaid, be in, upon, about, or with such Chattel or Article, or in, upon, about, or with any Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing in, upon, about, or with which such Chattel or Article shall have been sold or exposed for Sale, such Person shall be bound upon Demand in Writing delivered to him or left for him at his last known Dwelling House or at the Place of Sale or Exposure for Sale by or on the Behalf of any Person whose Trade Mark shall have been so forged or counterfeited, or used without lawful Authority or Excuse as aforesaid, to give to the Person requiring the same, or his Attorney or Agent, within Forty-eight Hours after such Demand, full information in Writing verified by Affidavit or declaration according to the Law of this Colony made before [such Court or Magistrate or Justice of the Peace as shall be required] of the Name and Address of the Person from whom he shall have purchased or obtained such Chattel or Article, and of the Time when he obtained the same; and it shall be lawful for any Police Magistrate, on Information on Oath of such Demand and Refusal, to summon before him the Party refusing, and on being satisfied that demand so verified as aforesaid ought to be complied with to order such Information to be given within a certain Time to be appointed by him; and any such Party who shall refuse or neglect to comply with such Penalty for Refusal Order shall for every such Offence forfeit and pay to Her Majesty the Sum of Fifty

Dollars, and such Refusal or Neglect shall be prima facie Evidence that the Person so
refusing or neglecting had full Knowledge that the Trade Mark, together with which such Chattel or Article was sold, uttered, or exposed for Sale or other Purpose as aforesaid, at the Time of such selling, uttering, or exposing was a forged, counterfeited, and false Trade Mark, or was the Trade Mark of a Person which had been used without lawful Authority or Excuse, as the Case may be.

Trade Mark, or setting forth any Copy or Fac-simile thereof; and in every Indictment, Information, Pleading, Proceeding, and Document whatsoever in which it shall be intended to mention any forged or counterfeit Trade Mark it shall be sufficient to mention or state the same to be a forged or counterfeit Trade Mark without further or otherwise describing such forged or counterfeit Trade Mark, or setting forth any Copy or Facsimile thereof.

XI. The Provisions in this Ordinance contained of or concerning any Act, or any Conviction not to Proceeding, Judgment, or Conviction for any Act hereby declared to be a Misdemeanor Civil Remedy. or Offence, shall not nor shall any of them take away, diminish, or prejudicially affect any Suit, Process, Proceeding, Right, or Remedy which any Person aggrieved by such Act may be entitled to at Law, in Equity, or otherwise, and shall not nor shall any of them exempt or excuse any Person from answering or making Discovery upon Examination as a Witness or upon Interrogatories, or otherwise, in any Suit or other Civil Proceeding: Provided always, that no Evidence, Statement, or Discovery which any Person shall be compelled to give or make shall be admissible in Evidence against such Person in support of any Indictment or Information for a Misdemeanor at Common Law or otherwise, or of any Proceeding under the Provisions of this Ordinance.

XIX. In every Case in which at any Time after the Thirty-first Day of March 1864, or earlier date one Thousand eight hundred and sixty-four [or after such earlier date as hereinbefore rticle with a specified] any Person shall sell or contract to sell (whether by Writing or not) to any Mark to be contract other Person any Chattel or Article with any Trade Mark thereon, or upon any Cask, that the Mark is ge-Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing together with which such Chattel or Article shall be sold or contracted to be sold, the Sale or Contract to sell shall in every such Case be deemed to have been made with a Warranty or Contract by the Vendor to or with the Vendee that every Trade Mark upon such Chattel or Article, or upon any such Cask, Bottle, Stopper, Vessel, Case, Cover, Wrapper, Band, Reel, Ticket, Label, or other Thing as aforesaid, was genuine and true, and not forged or counterfeit, and not wrongfully used, unless the contrary shall be expressed in some Writing signed by or on behalf of the Vendor, and delivered to and accepted by the Vendee.
