DEAR SIR,—I beg herewith to hand you an extract from the Log of the S. S. "*Pekin*" on a passage from Swatow towards Amoy, as under—

At 2.35 P.M. 17th December 1863 the Ship grounded slightly and passed over something supposed to be a rock, the lead giving 5 fathoms.

Bearings True { Clipper Point N.E. by N. $\frac{1}{2}$ N.
Pagoda Island N. by W. $\frac{1}{4}$ W.
Centre Double Island W. by N. $\frac{1}{2}$ N.

The Chart indicates no danger on these bearings nor was any known either to myself or the pilot. The wind blowing at the time fresh, with some sea on—the Ship's draft of water 15 feet 6 inches; and it being necessary to clear *Namoa* and the dangers to the Southward before dark, no examination of the danger touched could be made.—I am, dear Sir, yours faithfully,
