Preamble.

Whereas it has become necessary to make further Provision for the Public Service of the Colony for the year 1863, in addition to the charge upon the Revenue for the Service of the said year already provided for in the Estimates submitted to the Legislative Council: Be it enacted and ordained by His Excellency the Governor of Hongkong, with the advice of the Legislative Council thereof, as follows:—

Supplementary Estimates 1863.

I. A Sum not exceeding One hundred and fifty-two thousand Dollars shall be, and the same is hereby, charged upon the Revenue of this Colony for the Service of the year 1863, and the said Sum so charged shall be expended as hereinafter specified, that is to say:—
