No. 10 of 1866, entitled—"An Ordinance enacted by the Governor of Hongkong, with the Advice of the Legislative Council thereof, to apply a Sum not exceeding Eight hundred and Twentynine thousand Dollars to the Public Service of the year 1867;"

No. 11 of 1866, entitled—"An Ordinance enacted by the Governor of Hongkong, with the Advice of the Legislative Council thereof, for altering the Time of the Vacation of the Supreme Court, and to provide for the granting of Interim Injunctions in case of the Absence or Illness of the Chief Justice;"

No. 12 of 1866, entitled—" An Ordinance enacted by the Governor of Hongkong, with the Advice of the Legislative Council thereof, for imposing and regulating Stamp Duties in the Colony:"—
