

3. No person shall at any bidding advance less than \$50.

4. Immediately after the fall of the hammer, the purchaser shall sign a Memorandum of Agreement for completing the purchase according to these conditions, and shall on the same day give security of two householders, approved by the Government, each to the amount of one-twelfth of the total annual premium, for the due fulfilment of the contract, if approved by His Excellency the Governor.

5. The Monthly Premium shall be paid into the Colonial Treasury upon the Twenty-first day of each month.

6. All other information may be obtained from the Surveyor General.
