- Title of Deed, whether Deed of Assignment, Composition or Inspectorship. Deed of Assignment for the Benefit of Creditors.
- Date of Deed. The 12th day of May, 1887.
- Date of Execution by Debtor. The 12th day of May, 1887.
- Name and Description of the Debtor as in the Deed. LISBELLO JESUS XAVIER of Victoria, in the Colony of Hongkong, Compositor, called the "Debtor."
- The Name and Description of the Trustee or other Party to the Deed not including the Creditors. LUIZ MARIA XAVIER of Victoria, in the Colony of Hongkong, Compositor, and hereinafter called the "Trustee."
- A short Statement of the Nature of the Deed.
