UNDER the terms of a scheme of reconstruction sanctioned by the Chief Justice of the Supreme Court of Hongkong on the 21st day of October, 1899, an Agreement of Reconstruction has been entered into by me, the Official Liquidator of the China Borneo Company, Limited, in Liquidation, (hereinafter called the "Old Company") with a new Company registered on the 1st day of November, 1899, called "The China Borneo Company, Limited" (hereinafter called the "New Company").
