一按照一千八百七十三年第八條則例第十一款凡經領有牌照貯藏之火水必要載在原來之罐或係人滯後始分別入罐者即須載在該原罐之發賣之時止又須貯在地下掘成之坎坎內四圍須砌以磚上用鐵蓋密封該蓋全用鐵片做成或以木用鐵片鑲成亦可務使氣不能洩出或偶有失慎易於撲滅

二倘各英差到來察驗該領牌照之人須將其所有各貯火水之處或各罐火水一一帶領察驗又當該差察驗時要如何幫助即須照行

郵政總局如有此人可即到本局領取茲將原名列左

In combination with the above and in the inside of the packet in which the Tobacco is packed is a label upon which is depicted the distinctive mark or device of a pair of Sceptres above and beneath which are the Chinese characters:—**吉祥煙庄如意**

爲記 signifying the words:—KAT

CHEUNG Tobacco Firm, the Sceptre as mark,

in the name of the KAT CHEUNG who claim to be sole proprietors thereof.

The Trade Marks have been used by the Applicant in respect of the following goods, namely, Manufactured Chinese Tobacco in Class 45.
