ENTITLED

An Ordinance to amend The Widows and Orphans' Pension Fund Amendment Ordinance, 1902 (No. 12 of 1902).

BE it enacted by the Governor of Hongkong, with the advice and consent of the Legislative Council thereof, as follows:—

1. This Ordinance shall be read and construed as one with The Widows and Orphans' Pension Fund Amendment Ordinance, 1902.

Amendment of section 2 of Ordinance 12 of 1902. 2. Section 2 of The Widows and Orphaus' Pension Fund Amendment Ordinance, 1902, is hereby amended by striking out the words "annually fixed" in the ninth line of the said section and by substituting the words "fixed from time to time" in place thereof.

Objects and Reasons.

The amendment to be effected by this Ordinance is rendered necessary by the decision to adopt a monthly instead of a yearly rate of exchange for the payment of salaries fixed in sterling.

- 1. The definition of "Hill District" which occurs in section 2 of The Rating Ordinance, 1901, (No. 8 of 1901), is hereby amended by substituting for the figures "600" the figures "700".
- 2. Section 29 of The Rating Ordinance, 1901, (No. 8 of 1901), is hereby amended by striking out the figures "600" in the tenth line of the said section and by substituting the figures "700" in place thereof.

Objects and Reasons.

The object of this Ordinance is to prevent any question arising as to the scale of rates to be levied in the area between the 6.00-foot and 700-foot contours in the hill districts.

- 2. Section 6 of The Chinese Hospital Incorporation Ordinance, 1870, shall hereafter be read and construed as if the word "sixteen" appeared in the third line thereof in place of Ordinance of the word "twelve".

Objects and Reasons.

In view of the approaching opening of two new Hospitals it is considered necessary to take power to increase the maximum number of members of the Permanent Board of Directors and so strengthen the permanent working Committee.

An Ordinance to repeal Ordinance No. 5 of 1902.

1. The Land Registry Office (Fees) Amendment Ordinance, 1902, (No. 5 of 1902), is hereby repealed as and from the coming into operation of Ordinance 36 of 1902.

Objects and Reasons.

The object is to repeal No. 5 of 1902. It is expedient, if not necessary, to pass this Ordinance because though, as appears by the title, Ordinance 36 of 1902 intended to repeal Ordinance 5 of 1902, and does so by implication, yet there are no specific words of repeal, those words having been omitted by a clerical error not noticed at the time.
