Regulation made by the Governor-in-Council under Section 5 of the Dogs Ordinance, 1893, (Ordinance No. 5 of 1893), this 15th day of November, 1910.

No dog brought from Shanghai will be permitted to land in this Colony for a period of three months from this date.

No. 350.

Regulation made by the Officer Administering the Governmentin-Council under Section 20 sub-section (1) of the Liquor Licences Ordinance, 1898, (Ordinance 8 of 1898), as amended by Section 6 of the Liquor Licences Amendment Ordinance, 1909, (Ordinance 46 of 1909), this 15th day of November, 1910.

The Regulation made by the Officer Administering the Government-in-Council under the aforesaid Section of the Liquor Licences Ordinance, 1838, on the 2nd day of June, 1910, which was published in the *Gazette* of the 4th day of June, 1910, is hereby revoked as from 1st day of December, 1910.

No. 351.

Amendment to the Regulations in Table M of the Schedule to the Merchant Shipping Ordinance, 1899, made by the Governorin-Council this 15th day of November, 1910.

The Regulations as to Fairways in Table M of the Schedule to the Merchant Shipping Ordinance, 1899, made by the Governor-in-Council on the 4th day of February, 1908, under Section 25 (4) of the said Ordinance and published in the Gazette on the 20th day of March, 1908, and on pages 409-413 of the Regulations of Hongkong, 1910, are hereby amended as follows:—

By the addition at the end thereof of the following: -

VIII.—Naked and Portable Lights.

Restriction on Naked and Portable Lights. 25. No naked or portable light shall be used by any person on board any ship or other vessel in the waters of the Colony for any purpose, on deck or below, except the electric light, or candles, or oil lamps burning animal, vegetable, or such other oil as will not give off an inflammable vapour at a temperature of less than 120 degrees Fahrenheit when tested in the manner set forth in the Schedule to the Case Oil, and Bulk Oil, Rules, made under Section 6 of the Dangerous Goods Ordinance, 1873, (No. 1 of 1873) and published in the Gazette on the 16th day of March, 1906, and on pages 34-39 and 45-50 of the Regulations of Hongkong, 1910. And any person who is responsible for or is a party to a breach of this regulation shall be liable to a penalty not exceeding one hundred dollars or in default of payment thereof to imprisonment with or without hard labour for any term not exceeding three months.

No. 352.—It is hereby notified that His Excellency the Governor-in-Council made the following amendment in the Schedule to Government Notification No. 321 of 1910, viz.:—

In the last line of the fourth column the words "Every week-day" have been deleted and the words "every day" substituted therefor.
