Order made by the Governor in Council under Sections 3 and 4 of the Importation and Exportation Ordinance, 1915, Ordinance No. 32 of 1915, on the 14th day of March, 1918.

Rule No. 42, which was made the above Ordinance and was published in the *Gazette* of the 20th October, 1916, and which was amended by Orders in Council published on the 27th October, 1916, the 4th May, 1917, and the 22nd February, 1918, is further amended by inserting between the word "Portugal" and the word "Roumania" the words "Madeira, Porto Santo, the Azores".

NOTE 2.—It should be noted that the fact that goods have been transhipped in, or carried in transit through, a port in the United Kingdom, or in some British Possession, does not relieve the importer from the obligation to produce a certificate of origin and interest, or a certificate of interest, as the case may be, where such obligation would otherwise exist.
