No. 402.

Order made by the Officer Administering the Government in Council under section 7 of the Rating Ordinance, 1901, Ordinance No. 6 of 1901, this 10th day of October, 1918.

It is hereby ordered that a valuation of the tenements in the Colony for the year commencing 1st July, 1919, shall be made before the 30th day of April, 1919, or as soon thereafter as may be.

Order made by the Officer Administering the Government in Council under sections 3 and 4 of the Importation and Exportation Ordinance, 1915, Ordinance No. 32 of 1915, on the 17th day of October, 1918.

1. Rule 41 which was published in the *Gazette* of the 18th August, 1916, and which was amended in the *Gazettes* of the 19th October, 1917, and the 5th July and 27th September, 1918, is further amended by the deletion of the word "Spain" in paragraph (3) thereof.

2. The Schedule to Rule 41 of the rules made by the Governor in Council under the above Ordinance is amended as follows:—

(1) The following headings are deleted:—

Chemicals, etc., the following:—

- (B) Ammonia and its salts, whether simple or compound, and mixtures containing such salts (except ammonia liquor, liquefied ammonia, ammonium alum, ammonium carbonate, chloride, nitrate, perchlorate, sulphate and sulphocyanide, and nickel ammonium sulphate, and mixtures containing such ammonium salts);
- (B) Ammonia, liquefied;
- (B) Ammonia liquor;
- (B) Ammonium alum and mixtures containing ammonium alum;
- (B) Ammonium carbonate and mixtures containing ammonium carbonate;
- (B) Ammonium chloride, including muriate of ammonia and sal-ammoniac, and mixtures containing these substances;
- (B) Ammonium nitrate and mixtures containing ammonium nitrate;
- (B) Ammonium perchlorate and mixtures containing ammonium perchlorate;
- (B) Ammonium sulphate and sulphocyanide;
- (B) Barium sulphate;
- (B) Indigo, natural and synthetic;
- (B) Nickel ammonium sulphate and mixtures containing nickel ammonium sulphate;
- (C) Sodium bicarbonate.

(2) The following headings are added :—

- (c) Acid-resisting apparatus made of quartz and parts of such apparatus made of quartz ;
- (B) Carbon, coke oven ;
- (B) Carbon, pitch ;
- Chemicals, etc., the following :—
 - (B) Ammonia and its salts, whether simple or compound, and mixtures containing such salts ;
 - (B) Barium sulphate and mixtures containing barium sulphate ;
 - (c) Indigo, natural ;
 - (B) Indigo, synthetic ;
 - (B) Sodium bicarbonate ;
- (B) Grates and registers for heating purposes, and their component parts ;
- (B) Nicotine and its compounds.

NOTE (1).—See the *London Gazettes* of the 30th July and 6th August, 1918.

NOTE (2).—Rule 41 (Military Stores) was published in the *Gazette* of the 18th August, 1916, and amended in the *Gazettes* of the 19th October, 1917, and the 5th July, 27th September and 18th October, 1918. Amendments of the schedule to that rule were published in various numbers of the *Gazette*, and a consolidating schedule was published in the *Gazette* of the 10th August, 1917.

The prohibitions now in force are contained in the notifications published on the following dates :—

A complete list of notifications issued up to the end of 1917 was contained in Note (2) to Notification No. 8 of 1918, which was published in the *Gazette* of the 11th January, 1918.

NOTE (3).—Rule 37, published in the *Gazette* of the 8th December, 1916, prohibits the exportation of silver dollars and silver bullion, and Rule 38, published in the *Gazette* of the 4th May, 1916, prohibits the exportation of Chinese cash except to China.

NOTE (4).—There are special restrictions on exportation to Switzerland. See Notification No. 535 which was published in the *Gazette* of the 7th December, 1917, and the Proclamation of the 25th June, 1918, which was published in the *London Gazette* of that date.

NOTE (5).—The exportation of the goods mentioned in the above Schedule is prohibited as follows :—

- (1) Goods marked (A), to all destinations ;
- (2) Goods marked (B), to all ports and destinations abroad other than ports and destinations in the United Kingdom and British Possessions and Protectorates ;
- (3) Goods marked (C), to all destinations in European and Asiatic Russia and in other foreign countries in Europe and on the Mediterranean, except France and French Possessions, Italy and Italian Possessions, and Portugal, and to all ports in any such foreign countries ;
- (4) Goods marked (D), to all ports and destinations other than ports and destinations in the United Kingdom, British Possessions and Protectorates, France and French Possessions, and Italy and Italian Possessions ;
- (5) Goods marked (E), to all ports and destinations other than ports and destinations in the United Kingdom ;
- (6) Goods marked (F), to all ports and destinations in Sweden, Norway, Denmark, and the Netherlands.

NOTE (6).—Application may be made to the Superintendent of Imports and Exports for information as to the conditions on which special licences will be granted for the exportation of prohibited articles.
