## EXECUTIVE COUNCIL.

## No. 489.

Order made by the Officer Administering the Government in Council under sections 3 and 4 of the Importation and Exportation Ordinance, 1915, Ordinance No. 32 of 1915, on the 19th day of December, 1918.

The Schedule to Rule 41 of the rules made by the Governor in Council under the above Ordinance is amended as follows:—

There shall be added to the list of goods marked "C" all goods not already appearing in the list of goods prohibited to all or any destinations in the said rule as amended, with the following exceptions:—

- (1) Printed matter of all descriptions;
- (2) Personal effects accompanied by their owners.

Note (1).—See the London Gazette of the 27th September, 1918.

Note (2).—Rule 41 (Military Stores) was published in the Gazette of the 18th August, 1916, and amended in the Gazettes of the 19th October, 1917, and the 5th July, 27th September and 18th October, 1918. Amendments of the schedule to that rule were published in various numbers of the Gazette, and a consolidating schedule was published in the Gazette of the 10th August, 1917.

The prohibitions now in force are contained in the notifications published on the following dates:—

A complete list of notifications issued up to the end of 1917 was contained in Note (2) to Notification No. 8 of 1918, which was published in the Gazette of the 11th January, 1918.

Note (3).—Rule 37, published in the *Gazette* of the 8th December, 1916, prohibits the exportation of silver dollars and silver bullion, and Rule 38, published in the *Gazette* of the 4th May, 1916, prohibits the exportation of Chinese cash except to China.

Note (4).—There are special restrictions on exportation to Switzerland. See Notification No. 535 which was published in the *Gazette* of the 7th December, 1917, and the Proclamation of the 25th June, 1918, which was published in the *London Gazette* of that date.

Note (5).—The exportation of the goods mentioned in the above Schedule is prohibited as follows:—

- (1) Goods marked (A), to all destinations;
- (2) Goods marked (B), to all ports and destinations abroad other than ports and destinations in the United Kingdom and British Possessions and Protectorates;
- (3) Goods marked (c), to all destinations in European and Asiatic Russia and in other foreign countries in Europe and on the Mediterranean, except France and French Possessions, Italy and Italian Possessions, and Portugal, and to all ports in any such foreign countries;
- (4) Goods marked (b), to all ports and destinations other than ports and destinations in the United Kingdom, British Possessions and Protectorates, France and French Possessions, and Italy and Italian Possessions;
- (5) Goods marked (E), to all ports and destinations other than ports and destinations in the United Kingdom;
- (6) Goods marked (F), to all ports and destinations in Sweden, Norway, Denmark, and the Netherlands.

Note (6).—Application may be made to the Superintendent of Imports and Exports for information as to the conditions on which special licences will be granted for the exportation of prohibited articles.
