"In view of the serious economic position which is being created by the continued raising of rents in the southern portion of the Kowloon Peninsula, will the Government state what steps it is taking with a view to controlling or regulating such raisings of rents?"

- 1. Is it a fact that the Indians on the Gaol staff are recruited locally whilst the Indians in the Police are recruited in India? If so, what is the explanation? Will the Government put both Services on the same footing as regards the field for recruiting?
- 2. Was Government rice supplied to the prisoners in the Gaol during the rice control period last year? Was this rice inferior in quality to the rice which had been previously supplied?
- 3. Is the food which prisoners in the Gaol refused or were unable to eat added to surplus and sold by the Government? If so, how many pounds of surplus food was so sold during each month in the last six months of the year 1919?

By-law made under section 16 of the Public Health and Buildings Ordinance, 1903, Ordinance No. 1 of 1903.

By-law No. 1 of the Disinfection of Infected Premises By-laws contained in Schedule B of the Public Health and Buildings Ordinance No. 1 of 1903, and published in the Gazette on the 22nd day of February, 1918, as Government Notification No. 72, is hereby repealed and the following by-law substituted therefor:—

1. In the following by-laws the words "epidemic, endemic, contagious or infectious disease" shall mean and include plague, cholera, small-pox, diphtheria, scarlet fever, typhus fever, enteric fever, relapsing fever, puerperal fever, para-typhoid fever, cerebro-spinal fever, and yellow fever. The words "infected premises" shall mean and include any premises in which any person suffering from any epidemic, endemic, contagious or infectious disease is or has been recently located, and any premises in which any animal infected with plague or dead from the same has been found.
