No. 209.

*Regulation made by the Governor in Council under section 8 of the Dentistry Ordinance, 1914, Ordinance No. 16 of 1914, on the 15th day of April, 1920.*

Regulation No. 9 made by the Governor in Council and published in the *Gazette* of the 12th October, 1917, is hereby cancelled and the following substituted therefor:—

Every graduate of the dental departments of the Universities and Dental Colleges mentioned below, who holds a State Board certificate from the State in which the University or College of which he is a graduate is situated, shall be entitled to a certificate of exemption upon his satisfying the Governor in Council, with the advice of the Dental Board, that he possesses the aforesaid qualifications, that he is of good character, and that there is no reason rendering it undesirable that a certificate of exemption should be granted to him:—
