- No. 579.—With reference to Notification No. 484 published in the Gazette of the 17th September, 1920, it is hereby notified that the Imperial Shipping Committee wish it to be known that they are now prepared to receive from persons and bodies in any part of the British Empire who are interested with regard to ocean freights, facilities and conditions in the Inter-Imperial Trade, suggestions or representations in regard to any matters included in the scope of their terms of reference which are as follows, viz.:—
