SUPREME COURT.

No. 203.—Pursuant to the Public Health and Buildings Ordinance, 1903, as amended by the Public Health and Buildings Amendment Ordinance, 1927, it is hereby notified that a vacancy on the Sanitary Board which necessitates an election has occurred through the resignation of Mr. CARLOS HENRIQUE BASTO who was elected to replace Dr. ROBERTO ALEXANDRE DE CASTRO BASTO as a Member of the Sanitary Board during the absence from this Colony of the said Dr. BASTO and until he should return to resume his functions as an elected member of the said Board.

Nominations of candidates to fill the vacancy are invited.

Every nomination must be in writing, must be signed by two electors, countersigned by the candidate and delivered to the Registrar of the Supreme Court not later than 1 p.m. on Wednesday, the 5th day of April, 1933.

Section 11 of the said Ordinance, with provides for the substitution of members, is as follows:—

“If any member of the Board be at any time prevented for more than six months by absence or other cause from acting, the Governor may appoint, or if the member has been elected, the electors may nominate, some other person to replace such member, until he shall return or be able to resume his functions”.

The term of office of the said Dr. BASTO expires on the 8th day of December, 1933.
