WHEREAS by sub-section (1) of Section 64 of the Merchant Shipping (Safety and Load Line Conventions) Act, 1932 (hereinafter referred to as "the Act"), it is enacted amongst other things that His Majesty may by Order in Council direct that the provisions of Part II of the Act shall extend to any Colony:

And whereas by sub-section (2) of Section 64 of the Act it is enacted that the Foreign Jurisdiction Act, 1890, shall have effect as if the provisions of Part II of the Act were included among the enactments which, by virtue of Section 5 of the Foreign Jurisdiction Act, 1890, may be extended by Order in Council to foreign countries in which for the time being His Majesty has jurisdiction:

And whereas by paragraph (a) of sub-section (3) of Section 64 of the Act it is enacted that His Majesty may by Order in Council direct that any provision of Part II of the Act which is expressed to apply only to British ships registered in the United Kingdom shall apply to British ships registered in any country or part of His Majesty's dominions to which the provisions of Part II of the Act can be extended by virtue of the foregoing provisions of the said Section:

And whereas by virtue of an Order in Council dated the tenth day of November, nineteen hundred and thirty-two, made in pursuance of Section 67 of the Act, Part II of the Act came into operation in the United Kingdom on the first day of January, nineteen hundred and thirty-three:

Now, therefore, His Majesty, in pursuance of the powers conferred upon Him by the said Section 64, is pleased, by and with the advice of His Privy Council, to direct and it is hereby directed as follows:—

- 1. The provisions of Part II of the Act set out in the First Schedule hereto which are expressed to apply only to British ships registered in the United Kingdom shall apply to British ships registered in the Territories set out in the Second Schedule hereto.
- 2. This Order may be cited as the Merchant Shipping Load Line Convention (Colonial) No. 1 Order, 1933.
