ORDINANCE No. 39 of 1932. (COMPANIES).

WHEREAS by section 291 of the Companies Ordinance, 1932, it is provided that any person may inspect the documents kept by the Registrar of Companies on payment of such fees as may be appointed by the Governor not exceeding one dollar for each inspection.

AND WHEREAS it is also provided by the said section that any person may require a certificate of the incorporation of any company, or a copy or extract of any other document or any part of any other document, to be certified by the registrar, on payment for the certificate, certified copy or extract, of such fees as the Governor may appoint, not exceeding five dollars for a certificate of incorporation and not exceeding fifty cents for each folio of a certified copy or extract.

NOW THEREFORE I, Sir WILLIAM PEEL, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Excellent Order of the British Empire, Governor and Commander-in-Chief of the Colony of Hong Kong and its Dependencies and Vice-Admiral of the same, do hereby appoint the undermentioned fees for payment in respect of the following matters:—

For inspecting in respect of any company the register or any file or document—For each inspection	\$1.00
For a certificate of incorporation	5.00
For a certified copy or extract of any other document or any part of any other document where the copy or extract has been prepared in the office of the Registrar, per folio of 72 words	0.50
For a certified copy or extract of any other document or any part of any other document where the copy or extract has not been prepared in the office of the Registrar, per folio of 72 words	0.10

This Order may be cited as the Companies (Fees) Order, 1934, and shall come into force on the 1st day of September, 1934.

The Companies (Fees) Order (No. 2), 1933, published as Government Notification No. 596 of 1933, is rescinded.

No. 610.—With reference to notification No. 477 of the 22nd June, 1934, it is hereby notified that the Anglo-Netherlands Civil Procedure Convention of the 31st May, 1932, has been extended to the Colony of Curaçao with effect from the 29th June, 1934.

The authorities in the Colony of Curaçao to whom requests for service or for the taking of evidence should be transmitted are:—

1. regarding the islands Curaçao, Aruba, and Bonaire, the judge of the County Court on the Windward Islands at Willemstad (Curaçao), and the language to be used in communications and translations is Dutch;
2. regarding the islands Saba, St. Eustatius, and the Netherland part of St. Martin, the judge of the County Court on the Leeward Islands at St. Martin, and the English language is admitted.

This extension makes the Convention effective between the Colony of Curaçao and the Colony of Hong Kong.

NOTICE TO WIRELESS TELEGRAPH OPERATORS.

ISSUED BY THE POSTMASTER GENERAL, HONG KONG.

First Class, Second Class, Special "A" Certificates of Proficiency in radiotelegraphy and radiotelephony certificates issued under the 1927 International Regulations will remain in force for the duration of the International Radio-communication Regulations of Madrid, 1932. For this purpose it is necessary that any such certificates should be endorsed extending their period of validity accordingly. Holders of these certificates should apply to the Inspector of Wireless Telegraphy, General Post Office, Hong Kong, for a printed slip which, when obtained, should be pasted over the last page of the certificate.

Holders of the above mentioned certificates must therefore make application for these printed slips to the Inspector of Wireless Telegraphy forthwith, and when doing so they are advised to quote the number and date of their certificate.

Special "B" certificates are invalid as from 1st January, 1934.
