In Form No. 15, the figures "14" were substituted for the figures "11" in the seventh line. In Form No. 19, in the Notice, the word "or" was deleted, and the words "and nationality so far as is known," were inserted after the word "occupation" in the first line of paragraph 7 (4).

On Council resuming, the Attorney General reported that the Bill had passed through Committee with immaterial amendments, and moved that it be read

a third time.
