ORDINANCE No. 28 of 1917. (FERRIES).

In exercise of the powers conferred by section 5 of the Ferries Ordinance, 1917, the exclusion from the operation of that Ordinance of the ferry of Po Kee between Tap Mun Village and Tai Po, referred to in Government Notification No. 443 of 1934, is rescinded, such ferry having been discontinued.

In further exercise of the said powers the ferry named hereunder is excluded from the operation of the Ferries Ordinance, 1917, so long as—

- (1) no exclusive and conflicting licence is granted under the said Ordinance; and
- (2) only one vessel is employed in the service; and
- (3) the vessel employed is approved by the District Officer, and is duly licensed; and
- (4) the ferry adheres to a schedule approved by the District Officer; and

(5) all directions given by the District Officer as to terminal and intermediate places or ports of call are complied with; and

(6) the fares and charges at any time taken and made are approved by the District Officer.
