LIMITS OF THE TSUN WAN MARKET AREA.

Western Boundary.

A line running from the South Eastern corner of Tsun Wan Marine Lot No. 7 along the Eastern boundary of that lot and thence due north to the north side of Castle Peak Road.

Northern Boundary.

From the point where the western boundary meets the northern side of the Castle Peak Road along the northern side of the road to the southern corner of Demarcation District No. 449 Lot No. 8, thence due north to the point of its intersection with the demarcation line dividing Demarcation District No. 453 and Demarcation District No. 449 and thence due east to the northern extremity of Demarcation District No. 449 Lot No. 266.

Southern Boundary.

A line running from the south eastern corner of Tsun Wan Marine Lot No. 7 to and along the southern boundary of Tsun Wan Marine Lot No. 2 and thence along the southern boundary of the proposed TSUN WAN lay-out, as shown on the cadastral plan deposited in the District Office, South, and dated 28th February, 1929, to a point where it intersects the eastern side of the Texaco Approach Road.

Eastern Boundary.

A line running from the intersection of the southern boundary and the eastern side of the Texaco Approach Road along the eastern side of the Texaco Approach Road to a point where it intersects the Castle Peak Road thence north-westwards to the eastern end of the northern boundary.

ORDINANCE No. 34 of 1910. (NEW TERRITORIES
REGULATION).

In exercise of the powers conferred by section 6 of the New Territories Regulation Ordinance, 1910, the Governor in Council makes the following rules with regard to Tsun Wan Market:—

Tsun Wan Market Rules.

1. The market shall be used solely for the sale of fresh meat, fresh fish and fresh vegetables or such other commodities as may from time to time be specified.

2. Fresh meat, fresh fish and fresh vegetables shall not be sold or exposed for sale within the Tsun Wan Market Area except in the market: Provided that this rule shall not prevent the retail sale of fish by licensed boatmen below low water mark.

3. The site for each market stall shall be let to the person bidding the highest monthly rent at an auction conducted by the District Officer, South. If a stall be auctioned during the month, only a proportionate amount of the rent for that month shall be payable.

4. All rent for stalls shall be paid each month in advance at Tsun Wan Police Station where a receipt will be given.

5. In the event of any stallholder failing to pay his rent in advance during the first seven days of any month, his tenancy shall be deemed determined and the District Officer, South, shall be entitled to put up the stall to auction at once, and if necessary to evict the previous stallholder therefrom.

6. The District Officer, South, shall be entitled to determine the tenancy of any stall on giving to the stallholder one full month's notice in writing from the end of any month. Any person remaining in possession of a stall after his tenancy has been determined may be evicted from such stall.

7. If it appears to the said District Officer that any game of chance is played at any stall, whether for stakes or not, with or without the consent of the stallholder, it shall be lawful for the said District Officer to terminate the stallholder's tenancy at once and take possession of such stall and the balance of the rent paid shall be regarded as forfeited to Government.

8. The market shall be open to the public between 6 a.m. and 8 p.m.

9. Every stallholder, who absents himself from the Colony for a period exceeding one month, shall notify such fact to the District Officer, South, and report to him the name and address of the agent responsible for his stall during his absence.

10. No person shall make use of any avenue or thoroughfare of the market for the conveyance of merchandise not intended for sale or exposure for sale in the market.

11. No person shall hawk or cry any article whatever for sale in the market.

12. No stallholder shall keep any dog in the market, nor shall any person knowingly permit any dog to follow him into the market.

13. Every stallholder shall cause his stall to be properly cleansed as often as may be necessary to maintain such stall in a sanitary condition.

14. No stallholder shall suffer any garbage or refuse to remain on or be under or about his stall, and he shall keep the avenue or passage in front thereof in a cleanly condition.

15. No person shall throw any refuse on to the market avenue or thoroughfare.

16. Begging for alms and loitering in the market are prohibited.

17. No stallholder or agent for a stallholder shall act in any way prejudicial to the good order and cleanliness of the market.

ORDINANCE No. 7 of 1926. (POST OFFICE).

In exercise of the powers conferred by section 3 of the Post Office Ordinance, 1926, the Governor in Council makes the following addition to regulation 30 published as Government Notification No. 977 in the Gazette of 28th December, 1934, with effect as from 20th March, 1936.

Letters and Postcards will be accepted at Hong Kong for transmission by the undermentioned Air Mail Service to the destinations named and at the charges specified. The charges are inclusive of the regular postage.

The Postcards must be the standard postcard on sale at Post Offices.

The air mail for each country will be landed at the place named in brackets.
