In exercise of the powers conferred by section 4 of the Public Health (Sanitation) Ordinance, 1935, and of all other powers in that behalf enabling, the Urban Council makes the amendment of by-law 1 under heading "Cattle, Swine etc." set forth in Schedule A to the said Ordinance :—

**Amendment.**

By-law 1 is rescinded and the following by-law is substituted therefor :—

1. Annual licences, expiring on the 30th September of the year in which they are granted, for the keeping of swine,

and annual licences, expiring on the 31st December of the year in which they are granted, for the keeping of cattle, sheep and goats may be issued.
