ORDINANCE No. 10 of 1902. (TRAMWAY).

ORDINANCE No. 11 of 1920. (PLANTS).

In exercise of the powers conferred by section 2 of the Plants Ordinance, 1920, the Governor in Council rescinds regulation 2 of the regulations made under the said Ordinance set forth on page 789 of the Regulations of Hong Kong, 1844-1925, and substitutes the following regulation therefor:—

- 2. No person shall without lawful excuse sell, offer for sale, or have in his possession or under his custody or control any portion of any of the following plants:
- 1. Ardisia, All species各種羅傘花
- 2. Atalantia Hindsii山桔
- 3. Azaleas, All species各種杜鵑
- 4. Bamboo, All species各種竹
- 5. Bauhinia Blakeana 洋蹄甲
- 6. Camellia, All species各種香港茶花
