ORDINANCE No. 10 of 1899. (MERCHANT SHIPPING).

By virtue and in exercise of the powers conferred by sections 25 (4) and 42 of the Merchant Shipping Ordinance, 1899, the Governor in Council hereby further amends Table M in the Schedule to the said Ordinance as amended by Government Notification 509, published in the Gazette of 23rd July, 1937, as follows:—

Amendment.

Regulation 23, under the heading (V)—DANGEROUS GOODS ANCHORAGES, is rescinded, and the following regulation substituted therefor:—

Limits of Dangerous Goods Anchorages. 23. The Dangerous Goods Anchorages shall mean—
(1) the portions of the harbour within the following limits:—

THE NORTHERN ANCHORAGE.

Northern Anchorage. *Northern boundary.*—A line drawn from the southern side of Torpedo Depôt platform touching and extending to the eastward of Laichikok Point.

Southern boundary.—A west line drawn from Hankow Rock Buoy.

Eastern boundary.—A north line drawn from the outlying rock on the north-eastern side of Stonecutters Island intersecting the northern and southern boundaries.

Western boundary.—A north line drawn from the northernmost point of Stonecutters Island intersecting the northern and southern boundaries.

THE EASTERN ANCHORAGE.

Boundaries:—

On the North—Latitude $22^{\circ} 18' 36''$ N.

Eastern
Anchorage.

On the South—A line from the south-eastern corner of the Quarantine Anchorage to Devils Peak.

On the West—The eastern boundary of the Quarantine Anchorage.

THE WESTERN ANCHORAGE.

Northern boundary.—The southern limit of the Quarantine Anchorage, viz.:—The mast of the Royal Observatory at Kowloon bearing E. by S.

Western
Anchorage.

Southern boundary.—The mast of the Royal Observatory at Kowloon bearing east.

Eastern boundary.—The southernmost point of Stonecutters Island bearing north.

Western boundary.—A line drawn from the western extremity of Green Island.

(2) all that part of Tolo Harbour within the following limits and bounded—

On the East—By a line drawn north and south through Bush Reef.

On the North and South—By the mainland.

On the West—By a line drawn 353° and 173° (true) through the westernmost point of White Head and the north-east corner of No Kot Choi.
